Must be able to bend, reach, and lift. Kitty City shifts are in the morning and afternoon only. Requires talking to the public. Training required and provided by UAF.

<input type="checkbox"/>	UAF Rescue Ranch	Pet Food Bank: Help load and distribute cat and dog food once a month or help unload truckload donations. Must be able to lift heavy bags.
<input type="checkbox"/>	From your home	Phone Lines: Retrieve emails that are voice transcribed calls. Work one or two days a week from home, forwarding some emails to the appropriate UAF party or providing information to callers.
<input type="checkbox"/>	From your home	Grant Writing: Experience with grant applications is preferred.
<input type="checkbox"/>	Various Locations	Fundraising: Participate in events such as the rummage sale, Woof Down Lunch, Hike for Hounds, dinner/auction, dog washes, pet photo events, etc. Includes setup, teardown, and talking to the public.

- Will indemnify, defend, and hold harmless UAF and its officers, directors, agents, and volunteers from and against any and all liability, claims, demands, damages, lawsuits, injuries, losses, judgments, costs or other expenses whatsoever, sustained by any companion animal or any person as a direct or an indirect result of or in connection with my performance of volunteer activities for UAF or my breach of UAF's rules, policies, guidelines or programs or as a result of the failure to perform the volunteer services.
- Will promptly return any UAF property, records, and funds to the organization if I stop being a volunteer for UAF for any reason or upon UAF's request.
- Understand and agree that UAF may refuse volunteer applications for any reason.
- Understand that the UAF Board reserves the right to dismiss any volunteer who does not abide by the terms of this agreement or who in any way degrades the image of United Animal Friends.
- Have accurately and truthfully completed this Volunteer Application and Agreement.
- It is understood and agreed that this Volunteer Agreement and Liability Waiver is intended to be legally binding on me, as well as my heirs, executors, administrators, legal representatives and assigns.
